## Baseline

Calculations for this report are based on data collected for the 2020 calendar year. This includes information for the below emissions streams:

- Electricity
- Waste
- Transport
- Water

Several emissions streams have not been included in this report:

- Air travel – not possible during calendar year 2020
- Gas – no gas supply on site

## Actions

Actions that have been completed and tracked throughout the year have helped Like Butter reduce their carbon footprint, and reduce the impact it has on the environment.



### Electricity

- Solar System Installation – In March of 2020 Like Butter installed a 30kW solar system which will reduce carbon emissions by up to 37 tonnes each year.
- 100% green electricity has been added to grid supplied energy through Like butter's energy retailer.




### Waste

- Composting of wood shavings has been trialled and samples have been tested. Results show that the composted material is safe for use in domestic settings.


### General

- Offsetting of carbon emissions has also been implemented through GreenFleet. Certificates have not been provided. Moving into calendar year 2021 Like Butter has amended this and certificates for GreenFleet offsets will be available.



The above graph illustrates total emissions by stream excluding any abatements. Meaning all carbon produced at Like Butter is displayed above. Totalling 18.06 tonnes, these streams are then offset by solar feed in and green energy purchasing through Like Butter’s energy retailer.

## Your Net Footprint



The above graph outlines Like Butter’s Net Footprint, demonstrating that Like Butter is carbon neutral! In fact, Like Butter is in a carbon deficit position, offsetting more carbon than it produces.

## What's next?

Achieving carbon neutrality is a big achievement, but there's always more to we can do. By offsetting your existing emission streams with solar you've been able to achieve fantastic results We recommend:

- Continue working to reduce the amount waste generated on site.
- Investigate battery storage to reduce reliance on grid supplied energy or
- investigate the implementation of an EV that is charged by excess solar generation.
- Continue to track your emissions streams through the ClimateClever application.
- Reset your goals for the next 12 months, noting them down in the action section of the ClimateClever application.
